#### TWENTY ONE (21) YEARS OF EXPERIENCES - ACHIEVEMENTS SUMMARY

I have contributed to good governance and accountability through improvement in public expenditure, integration of planning, monitoring and evaluation and reporting practices and standards, data collection and analysis requirements for decision making. I have designed, rolled out several tools in the public and private sectors. I am also a trainer in monitoring and evaluation.

The few points below provide you with some of the key achievements I would like to highlight:

 Development, monitoring and reporting on the Millennium Challenge Account Benin Monitoring and Evaluation plan. Funded by the MCC, this is a five year compact with a total of USD 391 million USD focusing on strengthening Benin electricity sector.

I manage a budget of USD 5 million for the M&E activities.

- Development of close collaboration with State Institutions and sectoral actors as primary data source for the compact (utility, regulator, ministry, rural electrification Agency, etc.)
- Planning, budgeting, monitoring and evaluation system of Benin Ministry of Microfinance and youth employment : development of Sector performance reports for 2009, 2010, 2011 and 2012 and of business promotion center project to support entrepreneurship in Benin. This is a XOF F 600 million project funded by the UNDP.
- Development, rollout and monitoring of the national evaluation system for Government funded projects : National Evaluation Plan, standards and guidelines for evaluation and monitoring activities, capacity building requirements. I coordinated three training sessions on the evaluation of public policies for the staff in charge of monitoring of the 77 local government in Benin in order to strengthen the evaluation practice.
